### 3. WORKFLOW ENHANCEMENTS

A few improvements have been made in the workflow area.

### 3.1. My Tasks List Filter

The My Tasks list can now be filtered by workflow template name. This gives users the ability to focus on a particular list of tasks quickly and easily.

### 3.2. Postpone Approval Options in the Workflow Template

In the previous version of FileHold, the option to select any of the postpone approval options in the workflow template was limited to either sending to a previous activity or the workflow initiator, <u>OR</u> selecting the ability to add a one-time review activity. Enabling all the options was not possible. In this release, administrators now have the ability to enable all of the "restart from" options in the workflow template.

### 3.3. One-time Review Activity

A one-time review activity allows a user to insert a review task ad hoc to allow a workflow participant to request changes before they complete their own task. In FileHold 16.0, the one-time review activity could only be sent to a single user. In FileHold 16.1, the one-time review activity can be sent to a user or a group of users. If a group is selected, then only one participant in the group can complete the activity (1 of X option is enabled automatically).

When a user selects the "postpone approval" option, they are now prompted to select the user to complete the one-time review activity, due date, and any task instructions. By default, the due date for the one-time review activity is set to match the source activity due date. The one-time review activity due date can be extended past the source activity due date if a configuration setting is enabled. The setting AllowWorkflowDueDateExtension must be set to "true" in the web config file in *C:\Program Files\FileHold Systems\Application Server\LibraryManager*. If the configuration setting is enabled, the due date for all workflow activities is extended by the number of days specified in the one-time review activity. For example, if the one-time review activity is due in 10 days, the source and subsequent workflow activities are also pushed out by 10 days, thereby extending the workflow due date.

#### 3.4. Workflow Email Notifications

The workflow email notifications have been updated to include:

- Comments from participants
- Links to feedback attachments
- Activity title and description

The workflow status is now colour-coded:

- Green: Approved
- Yellow: Postpone approval
- Red: Not approved

Dates are also colour-coded:

- Green: Completed on date was on time.
- Red: Completed on date was overdue.

Links to the workflow status report, mobile client, FileHold Desktop Application, and Web Client are also included in the emails.

The notification subject was updated to include the friendly system name or server name and the count of notifications included in the body. The notification frequency from the subject was removed and added to the body.

**NOTE**: For workflows that started prior to upgrading to FileHold 16.1, the email notifications will be missing some links but this does not affect accessing the workflow information from the email. For workflows started after the upgrade, the links will display correctly in the emails.

### 4. AUTOMATIC DOCUMENT IMPORTATION

The Automatic Document Importation (ADI) mechanism allows importing a large number of documents into the system. Document versions can now be imported using the indirect metadata method. The versions of the document that need to be associated to each other must be defined in the CSV file in order for the system to connect the versions together. The association can be from a metadata ID, document version ID, document ID, external ID using a quick search, and internal ID.


ADI has also been improved for faster data transfer and no file size limits.

### 5. FILEHOLD VIEWER LEVEL 2 – ANNOTATIONS

Annotations allow users to add stamps, text, sticky notes, shapes, highlights and so on to documents in the FileHold library using the FileHold viewer level 2. Annotations can now be stored as a separate markup layer. Only one markup layer can be created on a document.

If a document has a markup, the "Has Markups" section in the metadata pane is set to "Yes" with a link to view the markup. Clicking the link will open the document with the markup layer visible.





Annotations can still be "burned" into the document (not a separate layer) by saving as a new version or a new document.

Pre-set annotations can now be created and stored for repetitive usage. In the previous versions of FileHold, the annotation properties were lost between documents and could not be stored. Now with annotation pre-sets, these can be created in Microsoft SQL and seen in the Annotation Pre-sets area of the viewer. System and metadata tags (similar to Assemble to PDF and Convert to PDF tags) can be used in the pre-set annotations. Four annotation pre-sets are available "out of the box": Expunged, Paid, Approved, and Rejected. To create custom annotations, such as custom stamps, signatures, and so on, contact the FileHold Professional Services team.

The following is an example of the pre-set "Paid" stamp that has been modified to include the Check # metadata field.

### 6. MINOR ENHANCEMENTS

Some minor enhancements have been made to FileHold.

#### 6.1. Tags for inserting system information into documents

New system tags are available for use in the following areas: Convert to PDF in a workflow, Assemble documents, and the FileHold viewer level 2 annotations.



- [[sys|now]] Adds the date and time right now. The format of the date and time can be specified such as [[sys|now|yyy-MM-dd HH:mm:ss]].
- [[sys|full-name]] Adds the full name of the current user.
- [[sys|user-internal-id]] Adds the user's ADAM object ID.

### 6.2. Optional base URL for Courier

A new configuration option "CourierBaseUrl" has be added to the web config file in C:\Program Files\FileHold Systems\Application Server\LibraryManager. This allows the base URL for Courier links to override the global base URL defined in the setting "URLForDownloads", if defined.

Having a separate URL for Courier allows customers with one or more web client applications to have differing links.

### 6.3. Close icon and Delete button

The Close icon and Delete button have been updated on various screens for consistency.



## 7. RESOLVED ISSUES

ID	Title
10755	(WebClient) Ability to turn off Schemas at the level of Advanced Search. The setting "DisableSchemasInSearch" option can be set to "true" in the C:\Program Files\FileHold Systems\Application Server\WebClient web.config file.
10766	(FDA) Issues found when performing multi-selection of items from a drop-down database lookup metadata field. When manually entering the values with a comma, only the first number in the list was captured.
10768	(FDA) Slow search load in the system with many schemas.
10769	(FOC) Add-in for Excel attempts to modify an ".xla" file. A setting called "FOCIgnoreExtensions" in the FDA.exe.config file contains a list of file extensions that should be ignored by FOC. By default, it contains the "xla" extension. When set to an empty value, XLA files are not ignored. Other extensions, for example "xlam" can be added to this list if necessary.
10772	(FDA) Ability to turn off schemas in advanced search due to slowness if more than 400 schemas exist in the list. The setting "disableSchemasInAdvancedSearch" option can be set to "1" in config file (%appdata%\FileHold\FDA\options.dat).
10774	Search by URL not working using the "Logon with Windows Authentication" link.
10796	"Contains in FTS" search operator does not work when searching on a metadata field.
10805	(Active Directory) Issues with synchronization when multiple domain controllers are available.
11189	(FDA and Web Client) 'Restore system default settings' option in the Settings menu does not work in the Users list.
11192	(FDA) 'Delegate Task' toolbar button is unresponsive upon invoking from the Administration > Workflow management > Status Report.
11224	Issues with Microsoft SQL Server freezing when archiving documents.
11226	(Courier) One-time license file size grows with allocated units which affects system performance.
11228	Workflow template option updated to reset a workflow when a new version of an existing document in the workflow is added or adding a new document.
11229	It was possible to restart a not approved workflow with not approved document versions. This behavior has been changed so that if a user restarts a not approved workflow and any documents were added or removed or a new version of a document was checked in since the workflow was not approved, the user will only be able to restart from the first activity.
11258	(Mobile FileHold) Could not add a document.
11259	(FDA) Search filter for an empty saved search related to Date metadata field defaults to today's date instead of blank.
11261	Cannot permanently delete a document that was imported via Automatic Document Importation (ADI).

12750	(FDA) Unexpected error occurred when attempting to view a workflow task with the 'Automatic refresh of tasks' option enabled.
12752	(FDA) Checkmark for the 'Delete input files sent to library' option was not retained when attempting to edit the Properties of an existing watched folder.
12789	(P2F) There could be duplicated "Print to FileHold" printers when the FDA is not cleanly shutdown.
12860	Signoff sheet shows signers in wrong order when using the merge tags in a workflow that converts to PDF.
12876	Automatically restarting a workflow should not change the original due dates of the workflow tasks.
12943	(FHIT) Exception thrown when attempting to export library configuration associated with an auto-tagged folder in a specific scenario.
12972	Unexpected error occurred when attempting to link offline documents with custom naming.

8495	(Workflow) Workflow exists without assigned documents.
8530	(FDA) Word table not correctly formatted in Brava viewer.
10825	Encrypted PDF files may not have their contents added to the full text search index in a specific scenario.
11319	(FHIT) It is not possible to export an arbitrarily large library tree at one time using FHIT. The actual number is limited by system performance and the number of TCP ports configured in the system.
12111	The [[sys user-id]] tag displays an internal user id instead of the administrator defined user id.
12168	(Courier) Cannot cancel a pending Courier transmission if the one-time license issued from a now locked license pack.
12183	Cannot install on a server with more than 15 characters in its name.
12208	Pre-checker may not be able to detect that a ASP.NET 4.5 component is missing.
12652	ADI cannot match a fully qualified drilldown menu field during an import.
